### **DMHC Issues Claims Payment All Payer Letter**

The passage of AB 3275 in late 2024 requires the DMHC to revise its existing timely claims payment and financial solvency standards regulations to conform to the new 30-day payment deadline (from 45 days). In order to facilitate an understanding of the changes, the Department has issued an All Plan Letter that explains the revisions that will be made through formal regulations later in the year. This release of the APL in draft form will allow for public comment in response to their outline. Comments can be made through end of day on February 28. The instructions are contained in the APL, [available here](#). APG can submit written comments upon input from our membership.
